I was once a Protestant, and I became a Catholic. The main reasons which led to this change will be found substantially stated in the following work. My quotations of Scripture are generally from King James's translation, mainly for the reason that this was the one used by me in my pursuit of the true Church.

My parents were Baptists; but until the age of thirty-two, I was not a believer in the truth of Christianity. My own observation of men and things, as well as the arguments of others, at length satisfied me that the system was divine; and I at once acted upon my convictions, and joined myself to the Disciples, in 1840. In 1843 I removed with my family to Oregon. After my arrival, and while I was temporarily located at Fort Vancouver, I attended High Mass as a mere spectator, on Christmas, at midnight.
